## **THE DUTIES OF THE CLERKS OF COURTS' OFFICE**

The powers, responsibilities and duties of the Clerk of Courts are found in the ORC Section 1901.31. The Clerks Office is a major processing center through which virtually all court and case documents flow. The Clerk issues, records, and files these documents in accordance with the Ohio Revised Code statutes, and local rules of the Court. It is essential to the efficient and effective operation of the court system that these documents always be processed accurately and on a timely basis. The Clerk is responsible for receiving, and accounting for all costs, fees, fines, bonds, payments, and other moneys payable to the court. This duty requires adoption of, and adherence to, strict accounting procedures as prescribed by the State Auditor's Office.

### **WHAT THE CLERKS OFFICE CAN DO**

- Help you understand how the court works and answer questions you may have about court procedures.
- Help you with scheduling information.
- Help you find information about your case and where you must go when you're at the courthouse.
- Answer questions about monies owed to the court.
- Direct you to other agencies that can provide assistance.

### **WHAT THE CLERKS OFFICE CANNOT DO**

- Give you advice or fill out forms for you.
- Recommend lawyers or bonding agents.
- Advise you what to say or write to the Court.
- Reschedule for the Judge.
- We do not give legal advice.

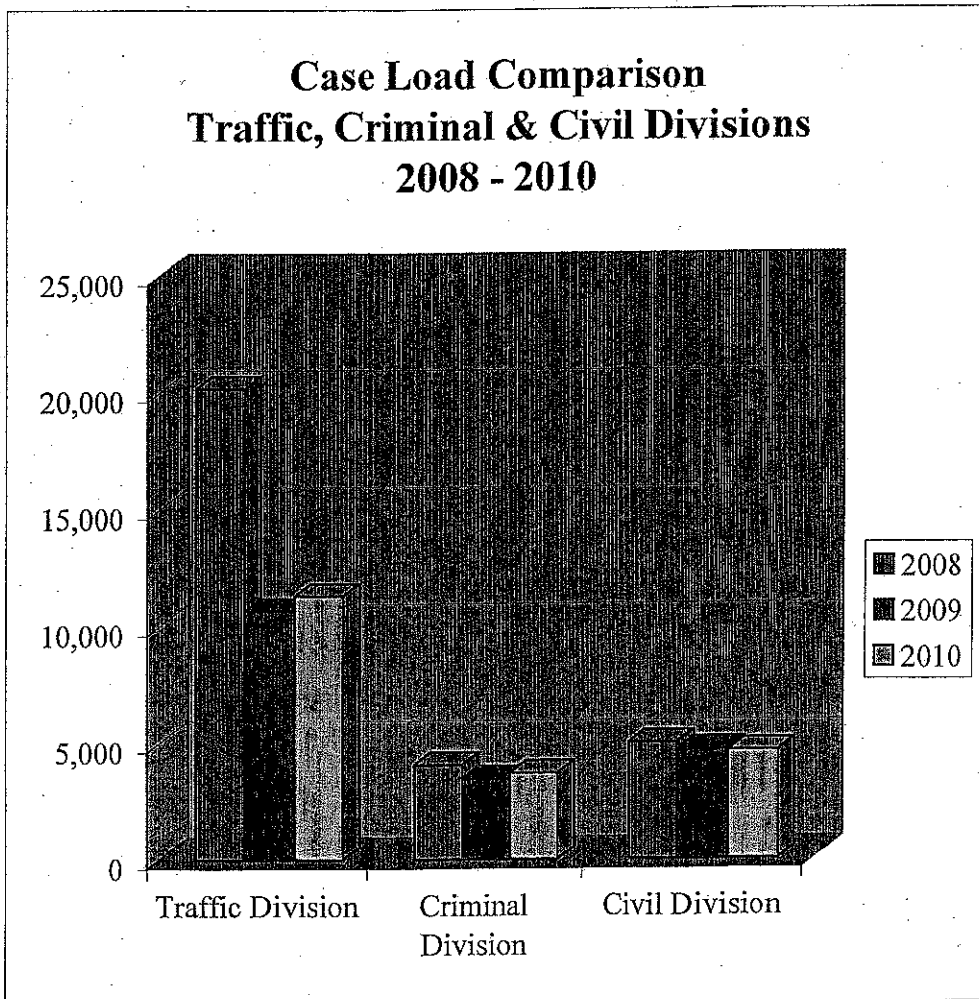

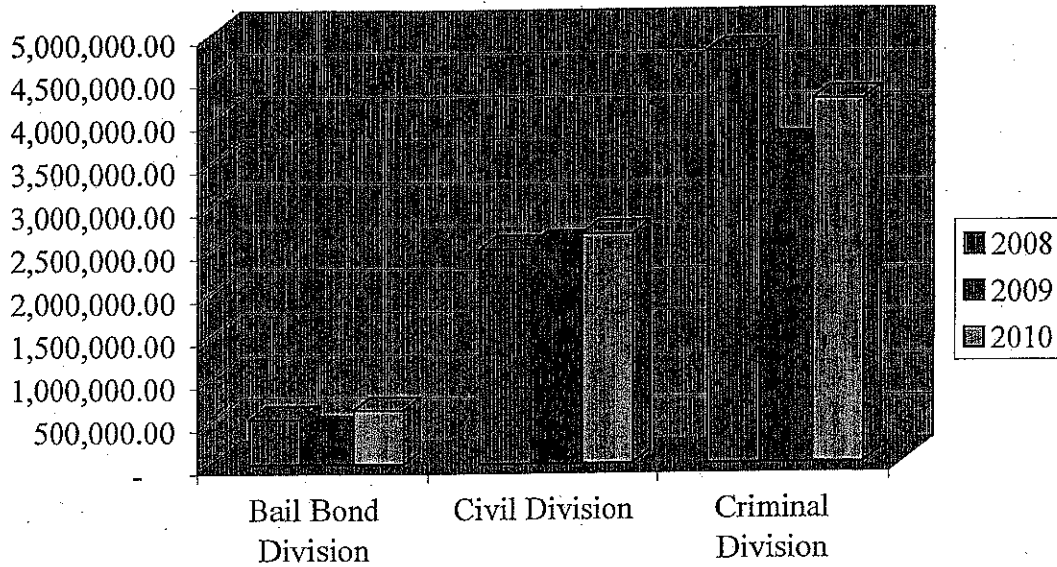

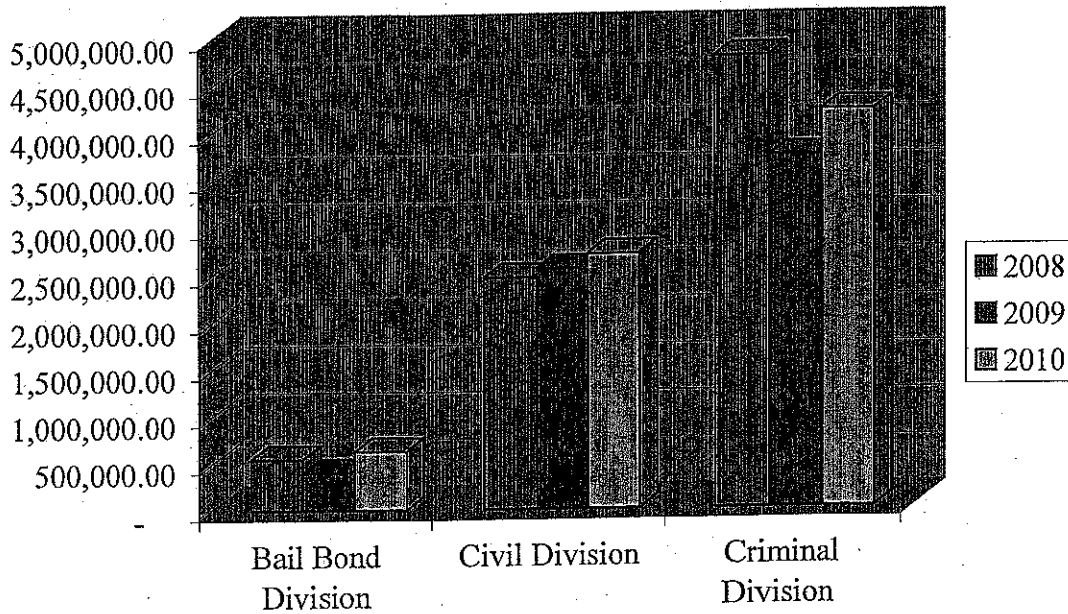
