A Message from the Clerk of Courts

2014 was a year of transformation in the Clerk's Office.

In the fall, we selected CourtView Justice Solutions to provide the courthouse's new case management system. CourtView replaces a system that was installed in 1995 and is designed for a paper-based court. The new system will allow us to move toward a paperless process, imaging court records and streamlining our operation.

As the year came to a close, we began installing CourtView and our new servers in the courthouse. Training and final implementation continued into 2015, with an anticipated go-live date in Q4, 2015.

Also in 2014, we began eliminating paper records that were taking up valuable space and requiring hours to fill some public records requests. Docket books were imaged and the case information can be accessed online in a matter of minutes.

We have continued to realign and reduce the size of our staff, automate formerly manual tasks, and make improvements to workflow so that our team can do more with less. In fact, the office now operates at its lowest budget level since 2001.

I welcome your feedback and suggestions on how we can improve our services. Please feel free to contact me. On behalf of all our staff, thanks for the opportunity to serve you and our communities.

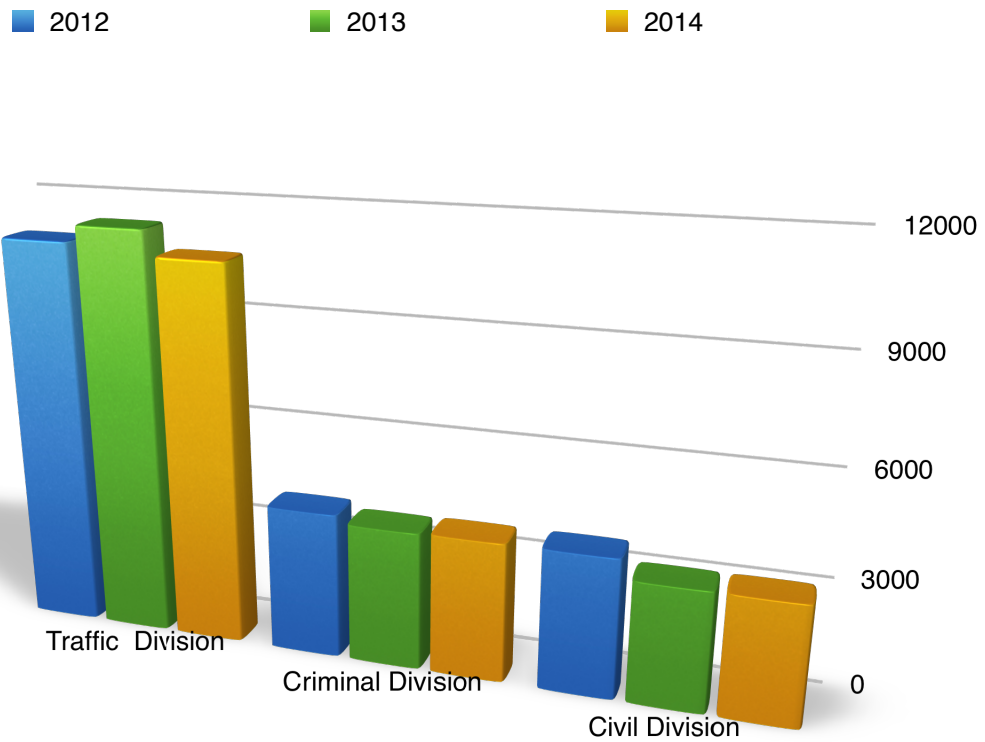

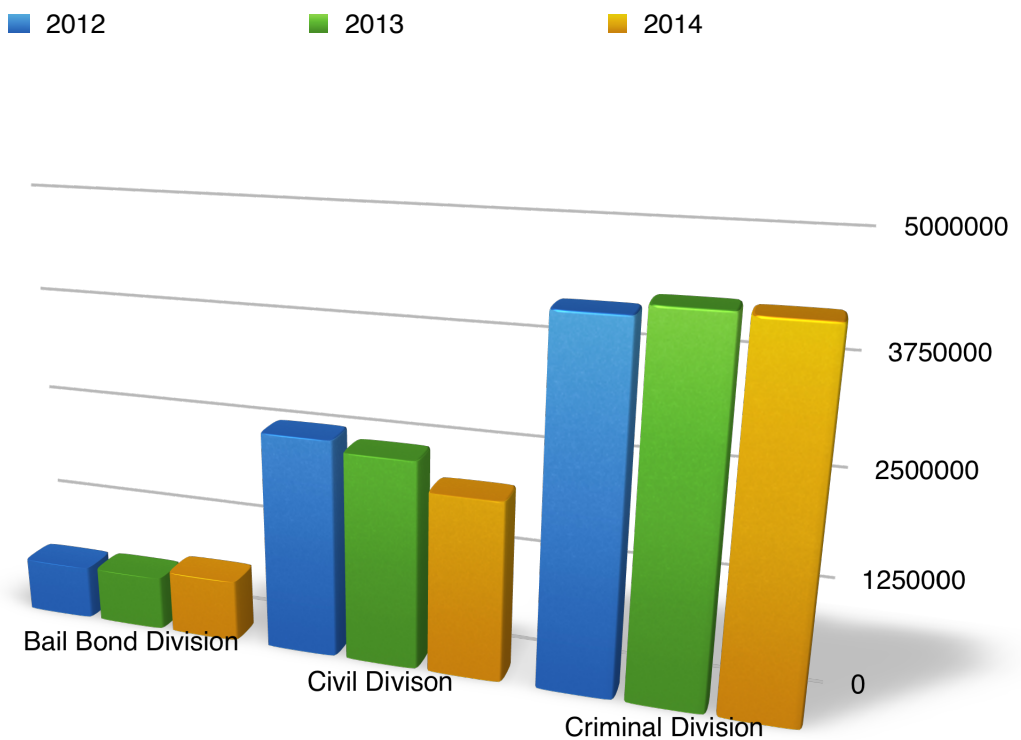

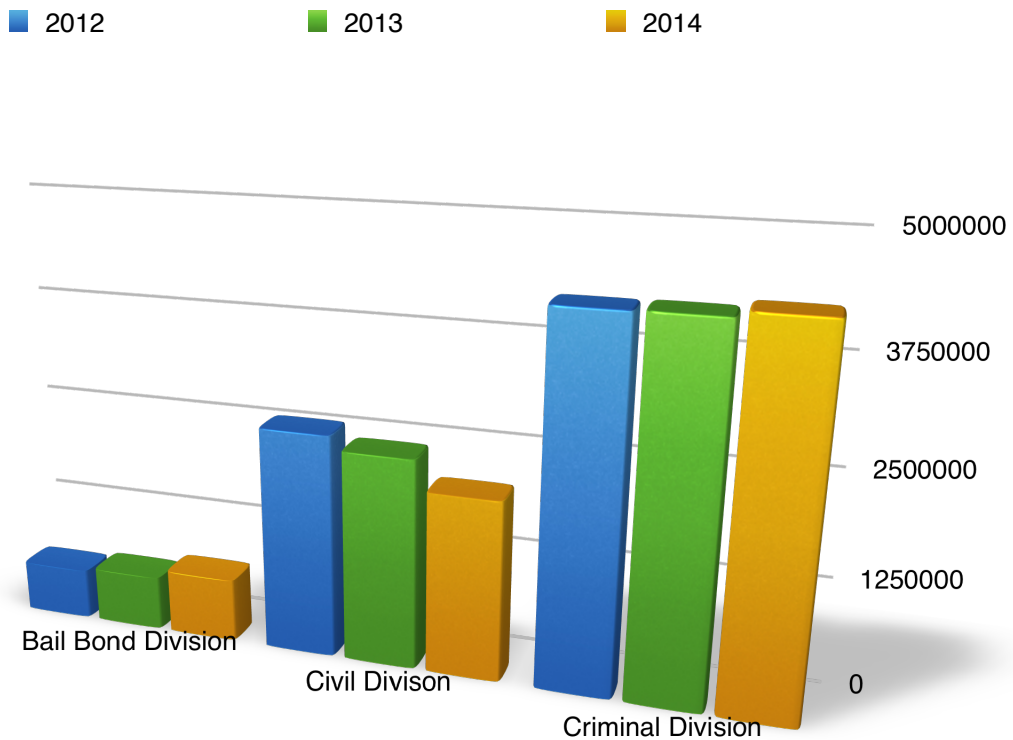
